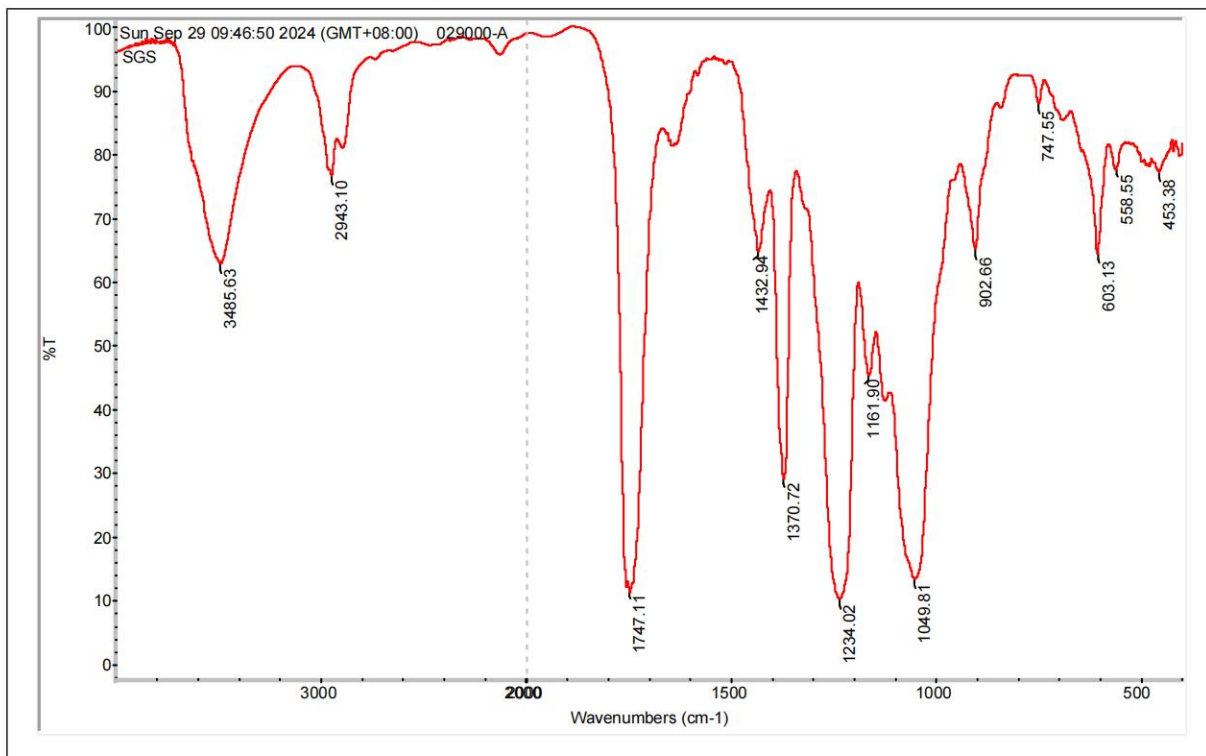

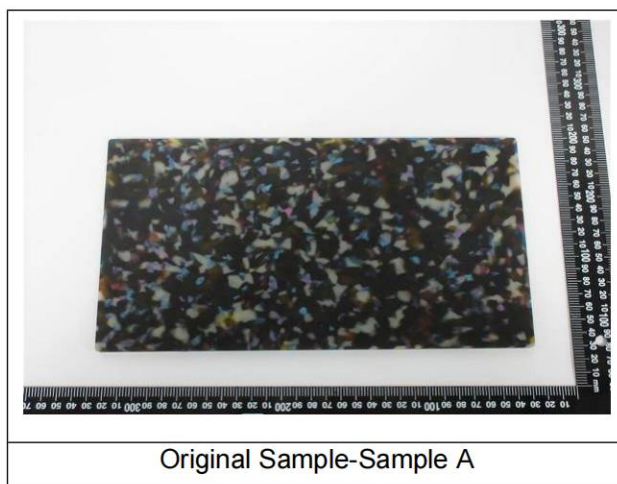

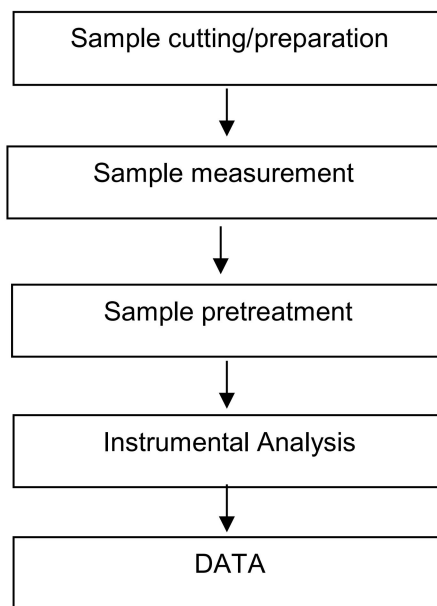

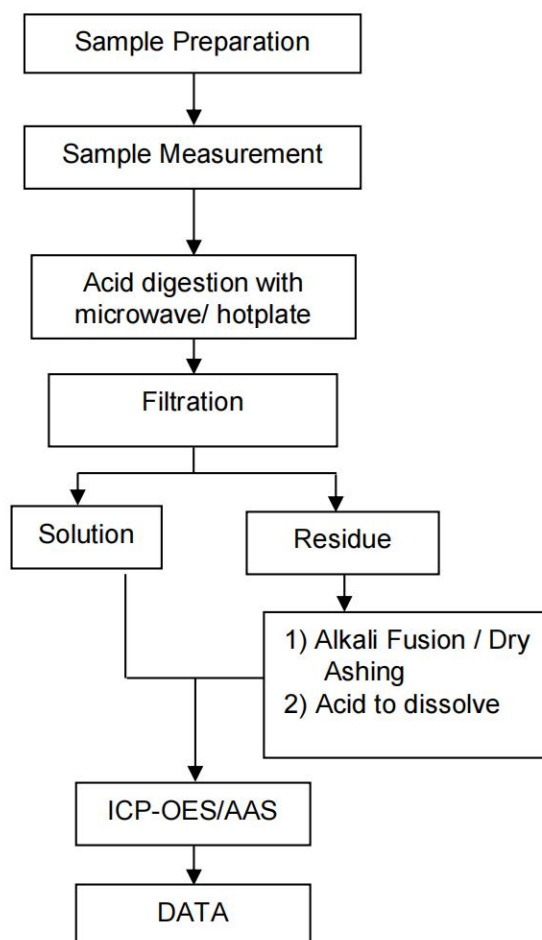

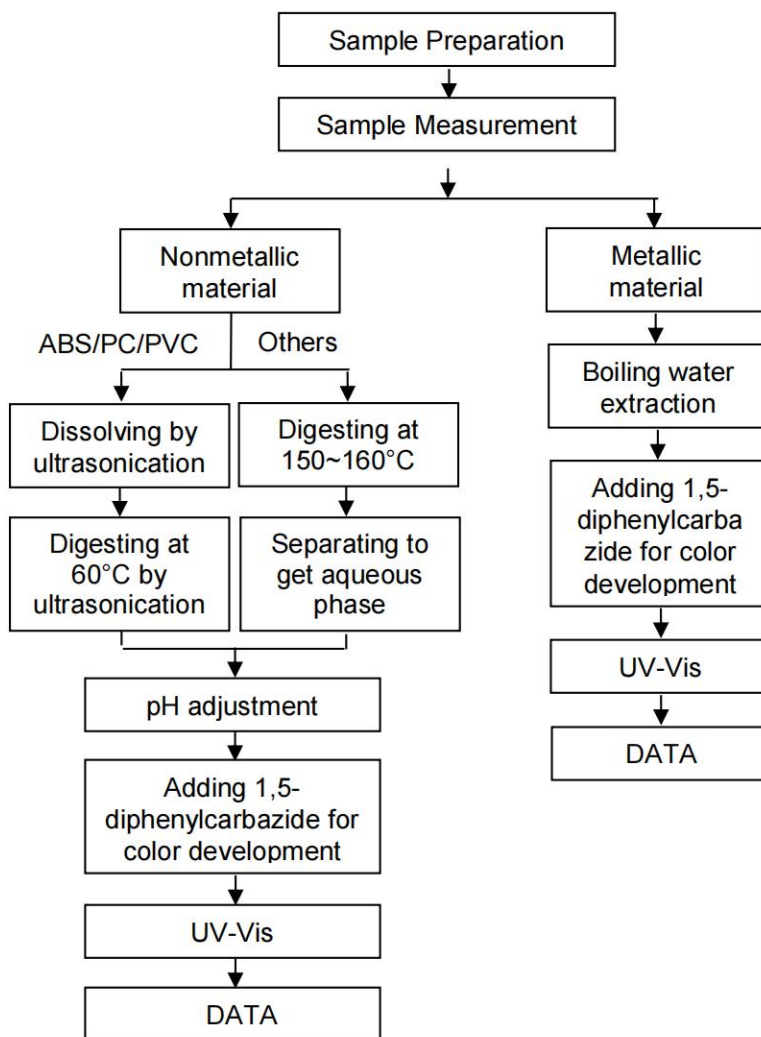

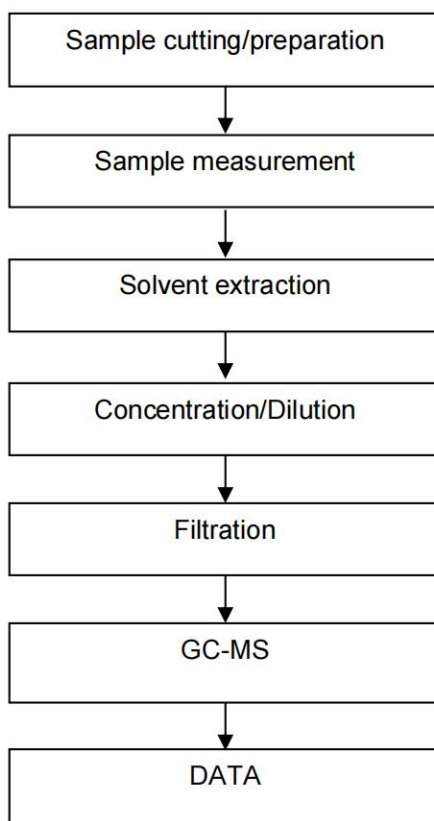

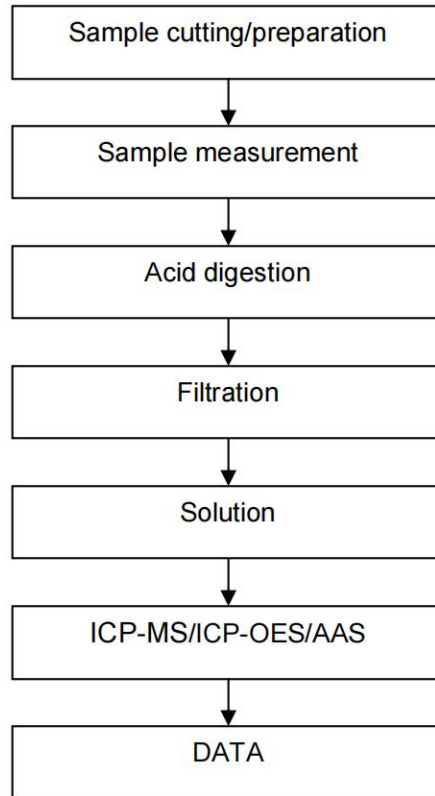

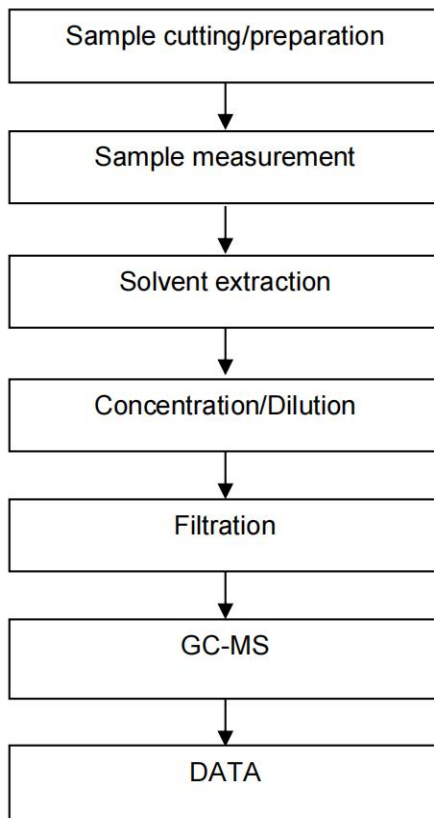

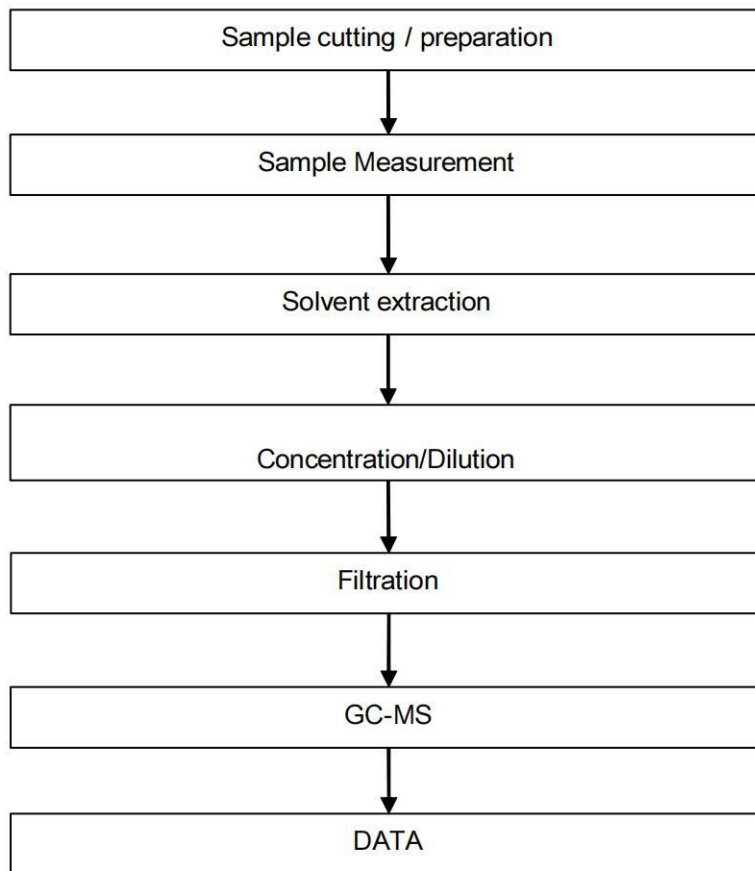

### Phthalates Testing Flow Chart



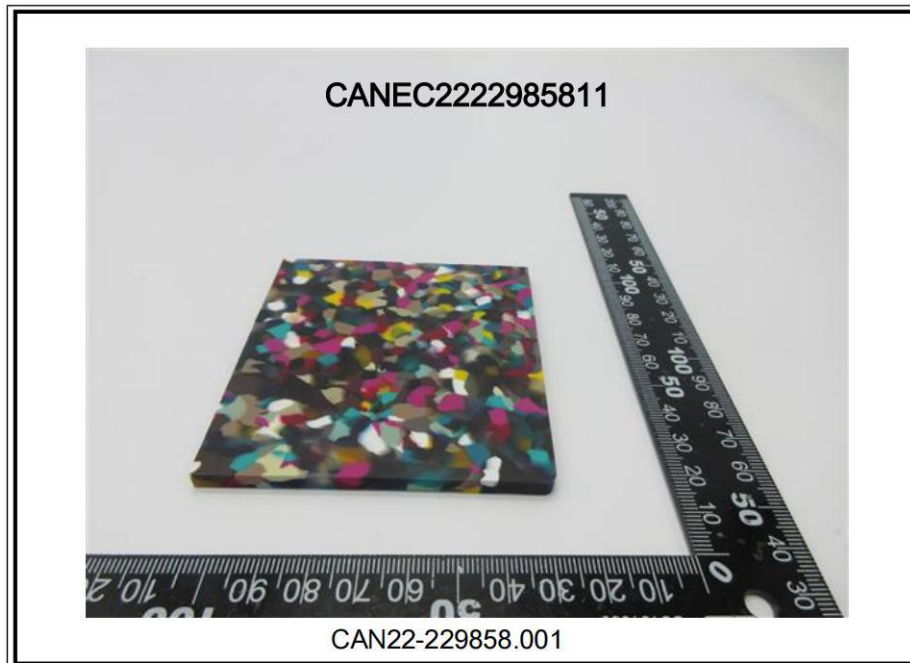

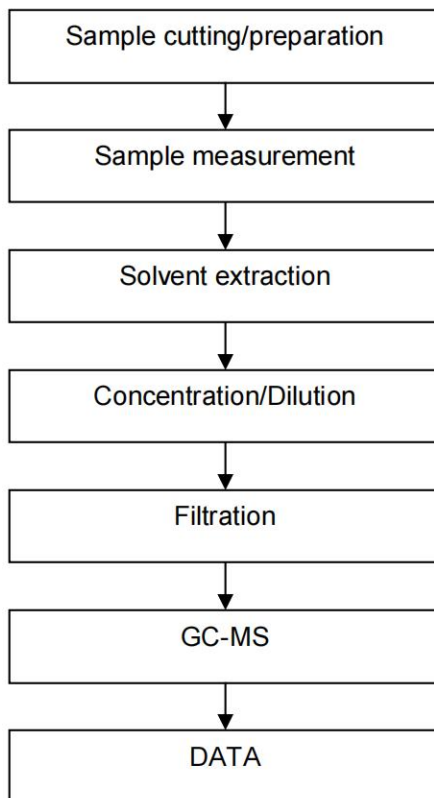

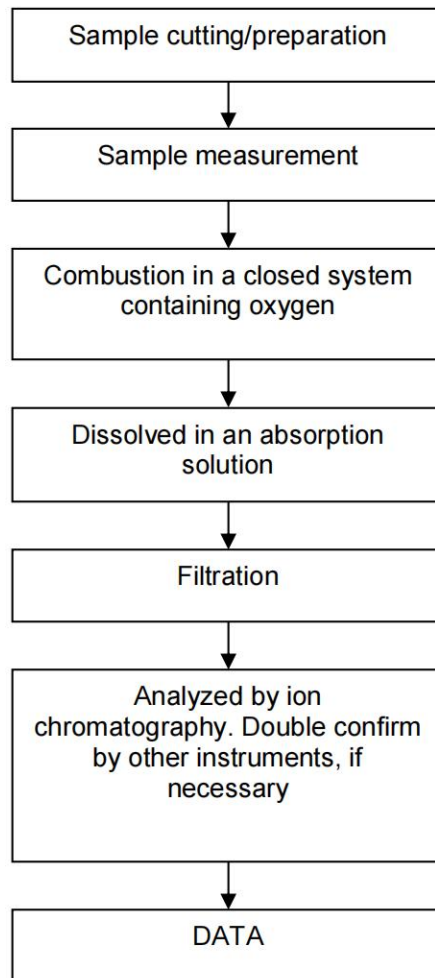

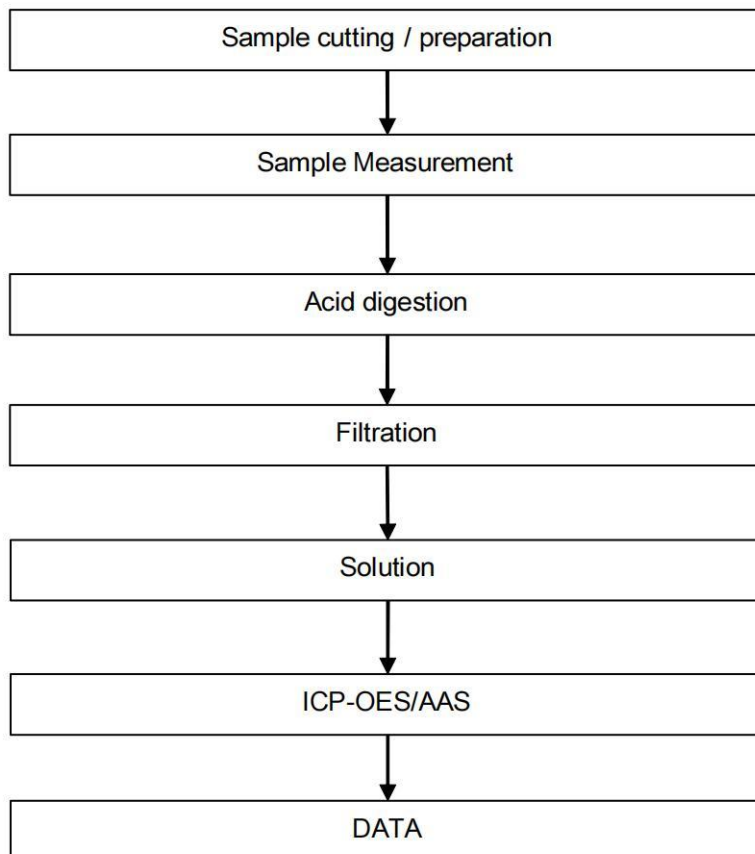

### Elementary Testing Flow Chart





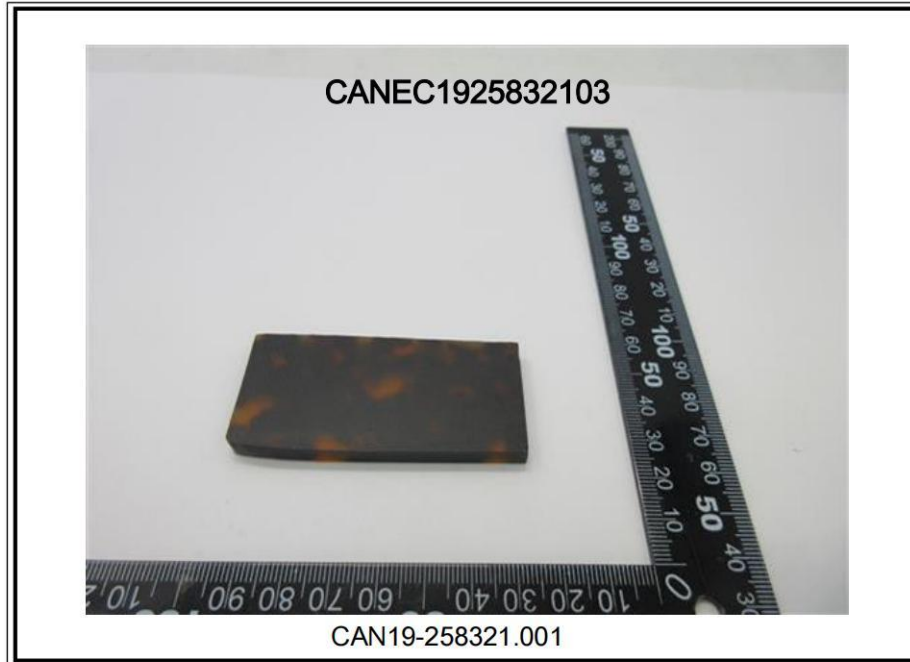
